Pursuant to Regulation 30 of the SEBI Listing Regulations, this is to inform that the Company has, on April 2, 2025 at 5:00 P.M., received an order dated April 2, 2025 ("Order"), issued by the Office of the Collector of Stamps, Chanakyapuri, Government of NCT of Delhi ("Collector of Stamps"), regarding the adjudication of stamp duty payable by the Company on the order dated September 30, 2019 passed by the Hon'ble National Company Law Tribunal, Bench-III, New Delhi, in the matter of the Scheme of Amalgamation involving Artemis Health Sciences Limited, Athena Eduspark Limited, Artemis Global Life Sciences Limited and the Company. The Scheme was effective from October 14, 2019.
