महोदया,

उपरोक्त संदर्भित पत्रांक के संदर्भ में उक्त परियोजना को पर्यावरणीय दृष्टिकोण से अनुमित देते समय अनुबद्ध शर्तों के अनुपालन सम्बंदित अनुवीक्षण प्रतिवेदन (मॉनिटरिंग रिपोर्ट) निम्निलिखित observations के साथ एतद् द्वारा संलग्न कर प्रेषित है:-

M/s Artemis Medicare Services Ltd. is expending a Hospital Complex at Sector 51. Gurgaon. It was found that the certified compliance report has been issued to the same project vide letter dated 23.08.2017 (Copy Enclosed). The EAC deferred the project and latest certified compliance report has now been requested vide minutes of the 15th meeting of Expert Appraisal Committee held on 29.11.2018.

In the present case, which has already considered as violation case, this report shall be treated as merely a monitoring report and not a certified compliance report and/or verification of remediation plan for recorded violation. Furthermore, certified complied report for violation cases neither been included in the notification dated 14.03.2017 nor circulars/guidelines issued by the Ministry. Regional Office of the Ministry under took site visit on the request of EAC and Ministry may like to clarify the matter from the PP to accord EC as deemed fit. It is inferred that implementation of some environmental safeguards needs sincere attentions with time bound action. It is further evident from the report that:

RWH pits were found filled with sludge and polluted water.

• Authorization under Bio-Medical Waste Management Rules, 2016 has not been obtained.

· Solar power unit has not been installed yet.

• Uploading of environmental reports, EC, and analytical data were not found on website of the hospital https://www.artemishospitals.com/.
